Position Description

MATERIALS ENGINEERING DEPARTMENT, FULL-TIME LECTURER. The Materials Engineering Department in the College of Engineering at Cal Poly, San Luis Obispo, is seeking to hire a full-time lecturer for academic year 2017-2018, to begin September 7, 2017.

Primary duties and responsibilities include teaching courses in the Materials Engineering department where appropriate. Experience with and the ability to teach Introductory MATE courses preferred. Ability to teach advanced courses in Materials Engineering preferred but not necessary.

Required Qualifications / Specialized Skills

A Master's Degree in Materials Engineering (or a closely related field with a strong engineering background) is required. All requirements for the Master's Degree must be completed before hire. The successful candidate must have strong knowledge and skill in one or more materials engineering sub-disciplines, with the ability to teach labs and/or lectures at the advanced undergraduate level.

Preferred Qualifications / Skills

Prior experience with teaching or industry experience strongly preferred.

Special Conditions (Staff)
